SPEECH COMPETITION: SIGN organized an insightful speech competition for +2 students, focusing on significant legal frameworks that safeguard the rights of tribal communities in India. The topics of the competition were the **Chotanagpur Tenancy Act (CNT Act)**, the **5th Schedule of the Constitution**, and the **Panchayats (Extension**



to Scheduled Areas) Act (PESA). The event was held at two locations within Ranchi District: Mandar on December 6, 2024, and Lohardaga on December 10, 2024. This event aimed to enhance the knowledge of students on these important legal frameworks that protect the rights of tribal communities in India. The competition served multiple purposes: a) **Awareness** Creation: Educating students about the laws that uphold the rights of Tribal people, b) Skill Development: Enhancing public speaking and research skills among Engagement: students. Civic c)

Instilling a sense of responsibility and the importance of active citizenship. The competition witnessed enthusiastic participation, with students showcasing their understanding of these crucial legal provisions through impactful speeches. Many participants highlighted the need for a stronger implementation of these laws to ensure justice and development for tribal communities. Competition held at Anne's +2 High School, the event saw **7 participants**. The winners were: in the First Poisition: Sanjana Lakra, in the second position: Nishi Riya Lakra and in the third position: Arjun Kujur, whereas competition held at Lohardaga had **36 participants** from two colleges: **Baldev Sahi College** and **Nandlal +2 High School, Arru**, where Roshni Bhagat from Nandlal +

High School, Arru secured the first position, Satish Lakra from Baldev Sahi College, Lohardaga secured second position and Aeram Saba from Nandlal + 2 High School was judged for the third position. The competition helped students develop deeper understanding of historical and constitutional significance of these laws. It also served as an eye-opener regarding the importance of



tribal rights and governance. According to the staff, such competitions are essential in building a responsible and informed society for the future. By sparking curiosity and passion among young minds, the speech competition succeeded in raising awareness about tribal rights and governance. Events like these play a vital role in preparing future leaders who are not only knowledgeable but also conscious of the socio-legal dynamics of the country.



- **Dr. Deonis Xess**, Senior Consultant Rheumatologist & Immunologist, Director, and Head of the Department of Rheumatology at Shalby Divine Hospital, who addressed issues related to joint and autoimmune conditions.
- **Dr. Anupa Khalkho**, a skilled Pulmonologist, who examined patients for respiratory health and lung conditions.
- **Dr. Suhagani Hembrom**, a renowned Gynaecologist & Obstetrician, who offered specialized consultations on women's health and prenatal care.
 - In addition to the consultations, several diagnostic tests were provided for free, ensuring a holistic approach to healthcare:
- BMD (Bone Mineral Density) Test, which helps in assessing bone health and the risk of osteoporosis.





• Free Eye Test, which helped identify vision-related issues and offered early detection of potential eye diseases.

The health camp benefited 50 individuals by providing free health service. This event highlighted the importance of accessible healthcare and

Rag Competition featured three teams from Birdih, Kyongsar, and Dahanga, while four teams from Birdih, Kyongsar, Kankushi, and Dahanga participated in the Tribal Dance

Competition. This event aimed to preserve and promote the rich cultural heritage of the tribal community, providing a platform for participants to showcase their traditional art forms and fostering pride and unity within the community. The Mausami Rag competition, a unique traditional musical event, allowed participants to perform seasonal songs that reflect the deep connection between tribal communities and nature, as well as the changing seasons. The Birdih team secured first place, Kyongsar took second, and Dahanga placed third in the Mausami Rag Competition. The Tribal Dance Competition was equally captivating, with participants performing traditional dances that are integral to tribal celebrations and ceremonies. Dahanga took first place, Birdih

secured second, and Kankushi earned third place. The competition highlighted the diversity of tribal dance forms, showcasing their



grace, energy, and cultural significance. This event was more than just a competition; it served as an opportunity for the younger generation to learn, appreciate, and engage with the customs and traditions of their ancestors. By organizing this event, SIGN provided the tribal community with a platform to connect with their cultural roots, while also raising awareness about the importance of preserving tribal heritage. This initiative reflects SIGN's commitment to supporting the cultural and social development of tribal communities. SIGN hopes that such events will continue to inspire and empower the tribal community, ensuring their heritage is celebrated and preserved for future generations. INTER-RELIGIOUS CHRISTMAS MILAN SAMAROH: On December 17th, in celebration of Christmas, SIGN organized an Interreligious gathering at the Social Development Centre. Priests from various religious communities were invited to speak on this



auspicious occasion. About 70 individuals different from communities attended, including representatives from the Christian community (Archbishop Vincent community Muslim Aind), (Maulana Abdul Manan Islahi from Jamate Islam). Sikh community (Dr. Devendra Singh), Tribal community (Ajay Toppo), and Hindu community (Swami Bhavesha Nand from Ramkrishna

Mission and BK Indu Sabu from Brahma Kumaris). They gathered to celebrate the Christmas Milan Samaroh. Each speaker emphasized the importance of coming together to promote peace and harmony among people of all religions. The Sisters from Daughters of St. Anne performed three beautiful Christmas carols, while the SIGN staff brought the nativity scene of Jesus to life. The program began with a group Christmas song by the SIGN team, followed by Bible reading from Luke 4:18-19 by Fr. Ranjana DSA, and a prayer by Fr. Bipin.
