

and also 'Who are Sub-recipients, Service Providers and Suppliers'? He said under Safeguarding policy, Reporting is mandatory and it is important there is proper Reporting Channels. Team discussed about the format of an agreement/oath to be taken by each staff. Finally, resource person said that Key Principles in Safeguarding is

Zero Tolerance, Survival Centred, Confidentiality, and non-retaliation. With this orientation program came to an end.

Monitoring Visit by Khilesh: As a part of Manos Unidas, Spain's Capacity Building Training to four of its partners including SIGN viz. Catholic Charities, Jamshedpur, Jan



Vikas Kendra, Hazaribagh, Samaj Vikas Kendra, Chandwa and Vikas Kendra, Simdega, SIGN, together with Khilesh Chaturvedu, the Freelancer and International Trainer, organized Monitoring system strengthening visit to all these partners. Fr. Bipin Pani, the Director and the legal holder for this capacity building training, along with Khilsh visited three centers viz. Jan Vikas Kendra, Hazaribagh, Samaj Vikas

Kendra, Chandwa and Catholic Charities, Jamshedpur. In all the centers, the team of Khilesh and Fr. Bipin attended their monitoring meeting. After each meeting Khilesh made some comments to improve the monitoring system. These visits also made to see whether organizations under observation are using the monitoring tools as discussed during the Monitoring and Evaluation Training. In all organization, it was noticed that though they are collecting the data and discussing about it, they are not analysing it. If it is under achieved, they should try to find out



the reasons for under achievement. And if they have achieved more than the desired goal, that also should be discussed, what are the reasons for more achievement. Khilesh suggested the team should discuss about the strategies to implement in coming quarters. Khilesh also suggested that each member of the implementing team should know about Result Based Monitoring system.
